

The Splunkie Awards 2024 aka The Splunkies- Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

THIS SPLUNKIE AWARDS AKA THE SPLUNKIES 2024 (THE "AWARDS PROGRAM") IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW AND WHERE REGISTRATION, BONDING, TRANSLATION OR LOCALIZATION REQUIREMENTS EXIST. THIS AWARDS PROGRAM IS ONLY OPEN TO SPLUNK CUSTOMERS, DEVELOPERS, AND PARTNERS. ANYONE WHO IS AT LEAST 18 YEARS OLD MAY NOMINATE AN INDIVIDUAL TO BE CONSIDERED FOR AN AWARD IN THIS AWARDS PROGRAM; **AN INDIVIDUAL MAY ONLY WIN IF HE OR SHE IS AT LEAST 18 YEARS OLD AND THE AGE OF MAJORITY IN HIS OR HER JURISDICTION OF PRIMARY RESIDENCE AS OF THE START OF THE AWARDS PROGRAM PERIOD AND A LEGAL RESIDENT OF AUSTRALIA, CANADA (EXCLUDING QUEBEC), DENMARK, FINLAND, FRANCE, GERMANY, INDIA, IRELAND, ISRAEL, ITALY, JAPAN, MAINLAND CHINA (EXCLUDING HONG KONG AND MACAU), THE NETHERLANDS, NEW ZEALAND, NORWAY, PHILIPPINES, RUSSIA, SINGAPORE, SOUTH AFRICA, SWEDEN, SWITZERLAND, TAIWAN, THAILAND, THE UNITED KINGDOM OR ANY 1 OF THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA (EXCLUDING PUERTO RICO OR ANY OTHER U.S. TERRITORY, POSSESSION, OR OVERSEAS MILITARY INSTALLATION), (SUCH JURISDICTIONS ARE REFERRED TO IN THESE OFFICIAL RULES AS THE "TERRITORIES")**. See Section 3 of these Official Rules for full eligibility details.

EACH AWARD WINNER WILL BE REQUIRED TO PARTICIPATE IN THE AWARD FULFILLMENT PROCESS AND SIGN DOCUMENTATION AS REQUIRED BY SPONSOR. SPONSOR MAY REQUIRE THE NOMINATOR OF AN AWARD WINNER TO COOPERATE WITH SPONSOR DURING THE AWARD FULFILLMENT PROCESS. EACH NOMINATOR AGREES TO COOPERATE AS REQUESTED.

THESE OFFICIAL RULES ARE A CONTRACT, SO READ THEM CAREFULLY. THIS CONTRACT INCLUDES PROVISIONS REQUIRING A NOMINATOR AND WINNER ("YOU") TO COMPENSATE SPONSOR (DEFINED BELOW) AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

Award recipients will be mentioned by name at Splunk's 2024 Annual Worldwide Users Conference - .conf[®]24 and via Splunk Blogs.

1. OVERVIEW. The Awards Program is sponsored by Splunk Inc. ("Sponsor"), and begins at 12:01:00 a.m. Pacific Time ("PT") on **January 31st, 2024 and ends at 11:59:00 p.m. PT on March 15th, 2024** (the "Awards Program Period"). The Awards Program is a nomination-based program where eligible nominees will be placed in 1 of 5 categories (see below for categories) and judged by

a panel of qualified judges using the criteria applicable to the Category (defined below) in which they are placed.

2. HOW TO NOMINATE. To nominate an individual in the Awards Program, you must visit conf.splunk.com/the-splunkie-awards.html (“Awards Program Site”) during the Awards Program Period and submit the following information for both you and the nominee: Full name, company, email address and telephone number and the following information about the nominee: the Category in which you are nominating the nominee and responses to five (5) Sponsor-provided questions about your nominee. All nomination responses must be truthful, accurate and non-offensive (as determined solely by Sponsor in its discretion), must not reflect negatively on Sponsor or any Sponsor employees, must be suitable for a public forum (as determined solely by Sponsor in its discretion) and must be stated in the nominator’s own words. In addition, the nominator must have all requisite rights to nominate his/her nominee.

The categories are (each, a “Category”): The Visionary, The Inventor, The Builder, The Guide, The Change Agent as more fully described below.

We're rolling out the red carpet to salute these game-changers for their outstanding contributions and fearless leadership.

The Change Agent

Are you making the world a better place? Are you improving the lives of others or advancing your organization’s mission to create positive social or environmental impact? If you or someone you

know is using Splunk to harness the power of data for good, we invite you to submit your nomination.

2024 Splunkie Partner Award Categories

Services Market Partner of the Year

This award celebrates a partner who has demonstrated innovation and resilience using Splunk products & technologies to deliver impeccable services with the ability to provide thoughtful consultative guidance to solve complex customer challenges that impact the market. This partner has gone above and beyond in their technology engagement with Splunk to deliver value to their customers with a proven ability to penetrate new markets with a joint value proposition.

Joint Selling Partners of the Year

This award celebrates partners (two or more entities) who have collaborated on joint selling efforts centered around Splunk products, technologies and services to close deals or boost sales that are mutually beneficial for all parties involved. These partners have gone above and beyond the call of duty to ensure customers receive innovative solutions while executing exceptional service throughout the customer lifecycle.

Technology Innovation Partner of the Year

This award celebrates a partner with exceptional expertise in building groundbreaking, repeatable solutions that interoperate with or depend on Splunk products and technologies. This partner has a proven ability to develop new technology that disrupts the market and addresses customer use cases across industry verticals. By delivering exceptional value and inciting transformative change, this partner has shifted the perspective on how we should be supporting customers with their innovative offering, thought process, and approach to generating new business models.

Social Impact Partner of the Year

This award celebrates a partner who propelled their company's corporate responsibility to create a positive impact socially, ethically, or environmentally. By customizing Splunk solutions to address core issues such as sustainability, well-being, diversity and inclusion, and more, this award celebrates a Partner who is creating a better world through innovation and resilience

Global Partner of the Year

This award celebrates the Elite partner organization that cranked up the volume on their commitment, engagement and investment in their partnership with Splunk. This Partner demonstrates proven value to their customers by leading with a business outcome approach to deliver innovative solutions that exceed customer expectations. We're rolling out the red carpet to salute this game-changer for their outstanding dedication to delivering customer lifecycle success.

Although the nominator selects the Category for his or her nominee, Sponsor reserves the right to consider that nominee for a different Category at Sponsor's sole discretion. NOTE: You may nominate yourself. The same nominator may not nominate the same nominee more than once per category.

Nominations must be submitted during the Awards Program Period at the Awards Program Site and

in strict accordance with Sponsor's instructions and restrictions and these Official Rules. A person may not pay or otherwise improperly influence (as determined solely by Sponsor in its discretion) a third party to submit a nomination. The Awards Program Site's server will be the official timekeeper for this Awards Program. Only nominations that are recorded by the Awards Program Site during the Awards Program Period will be considered.

Each nominator should review all personal information entered for accuracy purposes and make all corrections necessary to inaccurate data before submitting his/her nomination. By submitting, each nominator gives Sponsor permission, and represents that they have all necessary rights to grant such permission, to use such personal information submitted in connection with the Awards Program. See Section 9 below for additional information. Other proof of submitting or attempting to submit a nomination (such as, without limitation, a printed, saved or copied automated receipt confirming nomination or a "thanks for nominating" screen or message) does not constitute proof of actual receipt of the nomination for purposes of this Awards Program.

Nominations that do not abide by these Official Rules, the instructions of Sponsor and provide all required information will be disqualified in Sponsor's sole discretion. Nominations will not be acknowledged or returned. Nominations that are forged, altered, incomplete, lost, late, misdirected, mutilated, illegitimate, garbled, or generated by a macro, bot, or other automated means will not be accepted and will be void. Nominations originating at any web site other than as set forth specifically above, including, without limitation, through commercial promotion subscription notification or entering services, will be declared invalid and disqualified for this Awards Program. Sponsor may keep all nomination information for up to 5 years after completion of the Awards Program for business management and record keeping purposes. **NOMINATIONS WILL NOT BE ACKNOWLEDGED OR RETURNED AND MAY BE DESTROYED. KEEP A COPY OR THE ORIGINAL OF EACH ELEMENT OF YOUR NOMINATION. ANY NOMINATION THAT DOES NOT CONFORM TO THE REQUIREMENTS IN THESE OFFICIAL RULES WILL BE DEEMED INELIGIBLE IN SPONSOR'S SOLE DISCRETION.**

3. ELIGIBILITY: ANYONE WHO IS AT LEAST 18 YEARS OLD MAY NOMINATE AN INDIVIDUAL TO BE CONSIDERED FOR AN AWARD IN THIS AWARDS PROGRAM; HOWEVER, A NOMINEE MAY ONLY WIN IF HE OR SHE IS AN EXISTING SPONSOR, CUSTOMER, PARTNER OR USER, IS AT LEAST 18 YEARS OLD AND THE AGE OF MAJORITY AND A LEGAL RESIDENT IN ONE OF THE TERRITORIES LISTED ABOVE. The following entities and individuals are not eligible to win an award: Sponsor, its parent company(ies), divisions, affiliates, subsidiaries, advertising and public relations agencies or promotional partners associated with this Awards Program and the respective officers, directors, members, managers, employees, representatives, and agents of each of them (each, an "Awards Program Entity" and collectively, "Awards Program Entities"), and relatives of and those living in the same household as such individuals. For the purpose of this Awards Program, relatives are defined as spouse, partner, parent, legal guardian, in-law, grandparent, sibling, children and grandchildren. This Awards Program is void where prohibited by law.

In addition, Sponsor recognizes that federal, state, or local government (whether U.S. or non-U.S.) employees, as well as employees of regulatory agencies or entities owned or controlled in part by any government (collectively, "Government Nominee(s)"), may be subject to policies and regulations

Government Nominees may be nominated for this Awards Program, but are not eligible to receive all parts of the award if selected as a finalist or winner. 4. AWARD WINNER SELECTION & NOTIFICATION: The judging criteria for each Category are Content/Presentation (50%), Creativity (30%) and Category Relevancy (20%). These criteria will be applied to each nominee by a panel of judges made up of Splunkers, taking into account the specific Category in which a nominee is placed (see Section 2 of these Official Rules for the Category descriptions). **Customer award winners will be announced publicly at .conf24, after nominations close. Partner award winners will be informed prior to .conf24, after nominations close.**

Subject to applicable limitations, two (2) finalists and one (1) winner per customer Category and one (1) winner per partner Category will receive awards as described in Section 5 (twenty (20)). Total available awards: five (5) partner awards, fifteen (15) customer awards). In the event there is a tie among nominees in a Category, each tied nominee will win the applicable prize. In the event there are fewer nominees in a Category than there are awards available, Sponsor reserves the right to award fewer awards in that Category or award those awards to more than one (1) award winners in a different Category. **NOMINATORS DO NOT WIN AWARDS.**

There is a limit of one (1) award per person in this Awards Program. Award winners will be announced during the 2024 Splunk Worldwide Users conference (“conf24 / Global Partner Summit”). Each award winner may be required to complete, sign, have notarized (if applicable) and return to the address specified by Sponsor, without alteration and in the form presented by Sponsor, an affidavit of eligibility, declaration and/or liability/publicity release (unless prohibited by law) and tax forms (if applicable) in the timeframe specified by Sponsor or award may be forfeited. Award winners may disclaim all or part of the award if necessary to comply with applicable gifts and ethics rules. In the event of noncompliance with these requirements, the award may be forfeited and awarded to an alternate winner (time permitting and in Sponsor's sole discretion) based on the judges' scores. The affidavit of eligibility and liability/publicity release (if any) are subject to verification by Sponsor. Sponsor reserves the right to modify the notification procedures in connection with the selection of any alternate potential winner, if any.

Award winners need not be present to win, but need to be present to accept.

The total ARV of each award is \$1595.00 USD for in person. Notwithstanding the foregoing, any customer Category finalist who is a Government Nominee is only eligible to receive a front row seat to the Day 1 .conf24 Keynote.

Each customer Category winner (1 per category) will receive an in-person .conf24 pass with ticket to the search party, \$1595.00 , a personalized trophy, \$110, and credit to the Splunk store, \$100 USD. The ARV of each award is \$1805.00 USD for in person. Notwithstanding the foregoing, any customer category winner who is a Government Nominee is only eligible to receive a personalized trophy.

Partner Splunkie Awards: Each partner category winner (1 per category) will receive an in-person .conf24 pass with ticket to the search party, \$1595.00, a personalized trophy, \$110, and credit to the Splunk store, \$100 USD. The ARV of each award is \$1805.00 USD for in person. Notwithstanding the foregoing, any partner category winner who is a Government Nominee is only eligible to receive a personalized trophy.

All award details not specified in these Official Rules will be determined in Sponsor's sole discretion. If legitimately claimed, the awards will be awarded. All taxes, social security payments or other fees (including those applicable in your jurisdiction of primary residence) and other expenses not specified in these Official Rules as being provided as part of the award are the sole responsibility of the award winner.

Sponsor will not replace any lost, mutilated or stolen award or any award that is undeliverable or does not reach an award winner because of an incorrect or changed address or other contact information. No transfers, award substitutions or cash redemptions will be made. Sponsor reserves the right to substitute the stated award or portion thereof with another award or portion thereof of equal or greater value for any reason, including, without limitation, award unavailability. Award winners are strictly prohibited from selling, auctioning, trading or otherwise transferring any part of the award. An award winner's employer or other corporate entity he/she may be affiliated with has no right to claim an award winner's award. Additionally, if the winner is a Government Nominee, by accepting a prize in this Award Program, the winner represents that winner has participated in the Award Program in the winner's personal capacity and not on behalf of the winner's employer. If receiving an award from Sponsor in this Awards Program is not in compliance with an applicable corporate gift receiving or similar policy, Sponsor reserves the right to give the award to an alternate award recipient, in which case Sponsor will have no further obligation to the originally selected award recipient.

SUBJECT TO THE LIMITATIONS IN THE PRECEDING SENTENCE, SPONSOR EXCLUDES FROM THESE OFFICIAL RULES ALL CONDITIONS, WARRANTIES AND TERMS IMPLIED BY STATUTE, GENERAL LAW OR CUSTOM EXCEPT FOR LIABILITY IN RELATION TO A NON EXCLUDABLE GUARANTEE. Sponsor's decisions will be final in all matters relating to this Awards Program, including interpretation of these Official Rules and awarding of the awards. All nominators and nominees, as a condition of nomination, agree to be bound by these Official Rules and the decisions of Sponsor. Each nominator represents that his or her nominee has agreed to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from this Awards Program. Participants further agree to not damage or cause interruption of the Awards Program and/or prevent others from using the Awards Program. Sponsor reserves the right to restrict or void participation from any IP address if any suspicious nomination and/or participation are detected. Sponsor reserves the right, in its sole discretion, to void participation by any person who Sponsor believes has attempted to tamper with or impair the administration, security, fairness or proper play

of this Awards Program.

Sponsor's failure to or decision not to enforce any provision in these Official Rules will not constitute a waiver of that or any other provision. In the event there is an alleged or actual ambiguity, discrepancy or inconsistency between disclosures or other statements contained in any Awards Program-related materials and/or these Official Rules (including any alleged discrepancy or inconsistency in these Official Rules), it will be resolved in Sponsor's sole discretion. Participants waive any right to claim ambiguity in the Awards Program or these Official Rules. If Sponsor determines at any time in its sole discretion that an award winner or potential award winner is disqualified, ineligible, in violation of these Official Rules, or engaging in behavior that Sponsor deems obnoxious, inappropriate, threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to disqualify that award winner or potential award winner, even if the disqualified award winner or potential award winner may have been notified or displayed or announced anywhere.

The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. If any person supplies false information, obtains nominations by fraudulent means or is otherwise determined to be in violation of these Official Rules in an attempt to obtain any award, Sponsor may disqualify that person and seek damages from him or her and that person may be prosecuted to the full extent of the law.

If a dispute cannot be resolved to Sponsor's satisfaction as to who submitted a nomination, the nomination will be deemed ineligible.
